The NAAWS Committee, at its sole discretion will review, consider and if warranted, grant third party requests for permission to translate standards and/or derivative works as stipulate below.

Third party requestors shall fully execute this form in English, and submit such in digital (pdf) format to the NAAWS Committee Secretary in accordance with instructions that may be found on the NAAWS Committee website at www.naaws-committee.com.

Upon determination, the NAAWS Committee Secretary will communicate whether or not approval has been granted.

By signing below, if permission is granted in the future, I (we) hereby:

- Acknowledge and agree that permission for use is limited to the applicant's current documents' edition
- Attest that intended end use will deliver factual information, education, and promotion of architectural woodwork
- Agree to credit the *North American Architectural Woodwork Standards* and Sponsor Associations as the original source of the referenced material, suggested wording being: "Reprinted with permission of the *North American Architectural Woodwork Standards* Sponsor Associations: AWMAC and WI."
- Acknowledge and agree that permission may be revoked for improper use, distortion of the status and integrity of the cover image, or use in violation of this policy
- Agree to furnish the NAAWS Committee a copy of all documents in which the materials are used
