

## **NAAWS Committee Form 107 - Assignment of Rights**

**Whereas**, the Architectural Woodwork Manufacturers Association of Canada ("AWMAC") and the Woodwork Institute ("WI") (collectively the "Associations") have formed the NAAWS Committee to develop unified North American Architectural Woodwork Standards (the "Standard"), which will be jointly owned by the Associations, and:

**Whereas**, \_\_\_\_\_ ("Individual" or "You"), an employee of \_\_\_\_\_ (your "Employer" if applicable), wish to participate in the development of the Standard either as a member of the NAAWS Committee or as a contributor of materials to the NAAWS Committee for incorporation into the Standard.

**Therefore**, the parties agree as follows:

**Assignment of Rights** - You agree that all material and/or information in any manner created, conceived or modified in whole or in part by you relating to your NAAWS Committee service and work on the Standard (the "Work") shall be a "work made for hire," and that the Associations shall own all right, title and interest in and to the Work, including the entire and exclusive copyrights in the Work and all rights associated with the copyrights, including but not limited to, reproduction rights, distribution rights, the right to prepare translations and other derivative works, and rights to the Work in all formats and media.

You further agree that to the extent a Work does not constitute a "work made for hire," you hereby assign and agree to assign to the Associations ownership of all right, title and interest in and to the Work, including but not limited to ownership of the entire copyrights in the Work and all rights subsumed thereunder. With respect to any Work of visual art, you expressly waive any and all rights of attribution and integrity with respect to any and all uses of the Work. You agree to execute all papers, take all actions, and provide assistance as reasonably requested by the NAAWS Committee or the Associations to perfect their ownership of the entire copyright in each Work.

**Authority** - You and your Employer acknowledge and agree that your selection for service on the NAAWS Committee and the opportunities made available to you and your Employer by serving on the NAAWS Committee constitute good and valuable consideration for entering into this Agreement, the receipt and sufficiency of which you hereby acknowledge.
